IYG ("we," "us," or "our") is committed to protecting your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our website, www.iyg.org, and interact with our services.

1. Information We Collect

We may collect the following types of information:

- **Personal Information:** When you contact us, sign up for programs, donate, or subscribe to our newsletters, we may collect your name, email address, phone number, mailing address, and other personal details.
- **Non-Personal Information:** We may collect anonymous data such as browser type, IP address, and usage statistics through cookies and analytics tools.
- **Sensitive Information:** If you voluntarily provide information related to gender identity, sexual orientation, or other personal characteristics, we take special care to protect this data.
- **Mobile Information:** If you opt in to receive SMS or MMS text messages from IYG, we will collect your name, phone number, and indication of consent to receive texts.

2. How We Use Your Information

We use the information we collect for the following purposes:

- To provide and improve our programs, services, and resources.
- To communicate with you regarding events, updates, and advocacy efforts.
- To process donations and maintain accurate donor records.
- To enhance the security and functionality of our website.
- To confirm consent to receive SMS and MMS text messages, in compliance with applicable regulations.
- To comply with legal obligations.

3. How We Share Your Information

We do not sell or rent your personal information. However, we may share your information in the following situations:

- **With Trusted Service Providers:** Third-party vendors assisting with website hosting, payment processing, text messaging services, or email communications, subject to confidentiality agreements. Mobile information will not be shared with third parties or affiliates for marketing or promotional purposes.
- **Legal Compliance:** When required by law, such as in response to a subpoena or legal request.
- **With Your Consent:** If you opt into sharing information for collaborations or public advocacy efforts.

Text messaging originator opt-in data and consent will not be shared with any third parties, except (1) with vendors, consultants, and other service providers who need access to such information to carry out work on our behalf (and who will not use such information for their own purposes); or (2) if we believe disclosure is required by any applicable law, rule, or regulation or to comply with law enforcement or legal process.

4. Data Security

We take reasonable measures to protect your information from unauthorized access, loss, or misuse. However, no data transmission over the internet can be guaranteed as 100% secure.

5. Your Choices and Rights

You have the following rights regarding your personal information:

- **Access & Correction:** Request a copy of the personal information we hold about you and update any inaccuracies.
- **Opt-Out:** Unsubscribe from communications at any time by clicking the "unsubscribe" link in our emails or replying STOP to text messages.

- **Request Deletion:** Request that we delete your personal information, subject to legal and operational requirements.

IYG is committed to protecting the privacy of minors. We do not knowingly collect personal information from individuals under 13 without parental consent. If we learn that we have collected such data, we will take steps to remove it promptly.
